

14:15 -15:30 Panel I – "Making European democracy more vibrant: The Conference on the Future of Europe"

Making European democracy more vibrant entails a more participative democracy in which EU citizens and civil society are actively involved. The Conference on the Future of Europe (CoFoE) should not only promote the dialogue between EU institutions and EU citizens, but also allow the latter to get more involved in EU politics thus achieving increased social cohesion. Due to the pandemic, the Conference had to be postponed and the role of digital media in shaping democratic processes has become all the more important. The Conference aims to provide citizens the opportunity to contribute their ideas about what the EU should look like in five or ten years.
